Without medical fitness certificate any candidate will not be eligible for attending the viva-voce/ selection.

Personnel Officers of Concerned units are advised to send APARs for the last **(06) Six years** (i.e. 2017-2018 to 2022-2023) & updated Service Records in all respect of the above named candidates to this office on or before **16/11/2022** positively. In case APARs of any candidate are to be requisitioned from other Railways/Divisions/Units, then Controlling Officers may please ensure that special messenger is sent, if required, to collect the APARs in time.
