

Sub: Retention of leased accommodation at the previous place of posting.


Ref: WR's letter No. WR/HQ/ESTT(PPOL)/46/2020 (16980) Dt. 17.10.2023

Please refer to WR's letter dt. 17.10.2023 referred above regarding retention of leased accommodation of Shri Ashwani Kumar, DRM/RJT at his previous place of posting at New Delhi provided by RLDA.

The matter has been examined in Board office in consultation with Finance Dte and the following observation has been made:

- (i) Railway officers on posting as DRM are allowed to retain their Railway quarter at previous place of posting or leased accommodation at previous place of posting in the event of hiring/leasing of private houses by zonal railway for residential uses of Railway officers as per Board policy
- (ii) Allowing retention by officers of leased accommodation provided by PSUs/other organization is not covered under the existing policy which only deals with Railway quarter or leased accommodation provided by the Railways.
- (iii) In case of leasing of Private house by PSUs or other organization, Board's policy is not binding on the borrowing organization. The organization may any time refuse to allow retention of the quarter to the officer and asked him to vacate the leased accommodation to accommodate the next incumbent.
- (iv) DRM is a very sensitive post. Using the facility provided by a different organization may result in Conflict of Interest.
- (v) The officer on deputation cannot claim parity with officers posted in Railway prior to going as DRM as PSUs /other organizations provides additional benefits/facilities to the officers on deputation which are not available to officers working in Railways,

In view of the aforesaid observations, the instant case is not agreeable.
