**Sub: Tenure on Secretary to GM and Dy.GM/G posts.**

Transfer / postings of Railway officers are governed by guidelines contained in the Comprehensive Transfer Policy issued vide Railway Board's instructions of even number dated 31.08.2015, followed by clarifications / guidelines issued from time to time.

2. In this regard, in partial modification of Para 1(vii) of the above Comprehensive Transfer Policy, it has been decided that the maximum tenure on the post of Secretary to GM or Dy.GM/G or combined tenure on these posts, shall not be more than three years.
3. It has further been decided that all existing postings should also be reviewed in terms of para-2 above and immediate necessary action be taken to comply with the above instructions within one month from the date of issue of these instructions.
4. This issues with the approval of the Competent Authority.
