Notification

Sub:- Filling up the post of SSE/Estr., Pay Matrix Level-8 in Engineering Department/HQ against DPQ vacancies.

It is proposed to fill up 01 vacancies of SSE/Estr., Pay Matrix Level-8 against DPQ in Engineering Department/HQ. The break-up of vacancies is as under:-

Note: 01 vacancy of PwBD is being carried forward for 3rd promotional year due to non-availability of PwBD employees after going to extended zone in 2nd promotional year. Hence, the above vacancy is being filled with normal manner with the approval of competent authority.

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:-

Staffs in the immediate lower grade with a minimum two years regular service from the date of regularization are eligible for promotion. However, the condition of two years service should stand fulfilled at the time of actual promotion and not necessarily at the stage of consideration.

2. PROCEDURE FOR SUITABILITY:-

- I. The category of SSE/Estr. is classified as Non- selection post, hence staff is to be called in 1:1 ratio. The vacancy is to be filled up by seniority-cum-suitability.
- II. Suitability will be conducted on the basis of scrutiny of service record and grading of last three years APARs & D&A clearance.
- III. The candidates are to be secured 08 marks out of 15 as aggregate in three years APARS.

3. PROVISION OF RESERVATION:

- I. The conditions set out by the Hon'ble Supreme Court in the matter of Jarnail Singh Vs. Lachhmi Narain Gupta for extending reservation in promotion to SCs/STs has been complied viz Quantifiable data has been collected in the cadre of SSE/Estr.. Roster is also maintained in due compliance of the judgment of the Hon'ble Supreme Court in the case of R.K. Sabharwal Vs. State of Punjab.
- II. The above suitability is provisional subject to final outcome of judgment of Hon'ble Supreme Court, in the matter of Jarnail Singh & others Vs. Lachhmi Narain Gupta & others.

- III. Reservation for PwBD :- In terms of para- 13.2 of DoPT's O.M. 36012/I/2020-Estt. (Res.II) Dated-17.05.2022 duly circulated vide EEstt. Rule No. 168/2022, in previous vacancy cycle of DPQ non-selection (suitability), 01 post reserved for PwBD in 'LV' category, which remained unfilled and therefore it is carried forward to this vacancy cycle. Also, as per said para, "..... in the event of non-availability of PwBD candidates for promotion even in the extended zone, the

vacancy shall not be filled and shall be carried forward. In the subsequent year, if PwBD of respective category is not available, the same can be exchange with other categories of disabilities identified for it. If it is not possible to fill up the vacancy by reservation even by exchange, the reservation shall be carried forward for two subsequent recruitment years, where- after it shall lapse”.

- IV. The post is identified for PwBD category in terms of Estt. Rule No. 168/2022. Accordingly, one vacancy is reserved for PwBD(Low Vision) in last assessment year.

- V. As per decision given by competent Authority that “ if still no one suitable is found the RESERVATION is to be carried forward to next year which means vacancy of this year can be filled in normal manner but ensuring the next year’s vacancy will have relevant reservation applicable on it.
