Now, with the approval of competent authority (i.e. CCM & COM), the co-user permission in favour of **M/s Rajasthan Rajya Vidyut Utpadan Nigam Ltd.** is extended for another one year from **01.04.2017 to 31.03.2018.**

Rates Circular No.62 (G)/2017

The following terms and conditions to be followed:-

1. The Coal moved by the private siding of M/s Sarguja Rail Corridor Pvt. Ltd. (Ramanujnagar) shall be booked under priority "C".
2. The first priority will be given to the traffic of M/s SRCPL for placement of empties and withdrawal of rakes.
3. The responsibility for clearance of all tollage liability (such as freight, demurrage, siding charges and other charges) which will be accrued due to use of your siding by co-user will be paid by you.
4. There should be no inconvenience to the work of siding owner during the use of siding.
5. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
6. The grant of this co-user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
7. The siding will remain open for 24.00 hrs. working.
8. In case of failure for making the payment of any dues, the facility will be withdrawn immediately.
9. In case of exigencies if any, the siding has to be vacated immediately.
