Reference is invited to this office Rates Circular cited above, wherein rate of siding charges of Ponri Hill Colliery siding was revised on the basis of per 4-wheeled wagons w.e.f. 01.07.2016.

Now, as per fresh time & motion study of the above siding, the rate of siding charges for Ponri Hill Colliery Siding has been revised **on per round trip basis**. The rate of siding charges will be levied @ **Rs.1,49,730/- (Rupees One Lakh Forty Nine Thousand Seven hundred Thirty only)** for double Electric engine for placement & drawing-out of rake with effect from **10.05.2017**.
