The content of the Railway Board's letter No.TCR/1078/2016/05 dated 30.06.2017 (Rates Circular No.20 of 2017) is reproduced below :-

- 1.0 Please refer to Board's letter of even number dated 31.03.2017 (Rates Circular No.15 of 2017) notifying minimum distance for charge and concession in charging of freight for all traffic booked up to 100 Kms. These instructions are valid up to 30.06.2017.
- 2.0 The matter has been reviewed and it has been decided that above instruction will continue to remain in force **from 01.07.2017 to 30.09.2017.**
- 3.0 All other details of the Rates Circular referred above will continue to apply unchanged.
- 4.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
