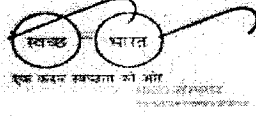

Please refer to this office Rates Circular No.193(G)/2015 dated 24.11.2015, wherein 3(three) rakes of BRNA wagons fitted with special fixtures for carrying 260 mtrs. long rail in 5 tier, procured under SFTO Policy by M/s Jindal Steel & Power Limited for R&UBM Private Siding (Alpha Code RJKN) was notified.

Consequent upon approval of Railway Board vide their letter No.2017/TC(FM)/4/6 dt.09.10.2017, extension has been granted to M/s Jindal Steel & Power Limited for transportation of 18 mts. long rail from their R & UBM Private Siding/Kirodimal Nagar (Alpha Code: RJKN) to New Bhaupur siding (Alpha Code: NBPM) by Dedicated Freight Corridor Corporation of India Ltd. (FCCIL) served by Maitha Railway station for the period of 6 (six) months (**i.e. from 28.10.2017 to 27.04.2018**) for receiving RMC cargo.
