The above permission is subject to fulfillment of following terms and conditions:-

1. First priority will be given to the traffic of siding owner for placement of empties and withdrawal of rakes.
2. The above firms will be responsible for clearance of all tollage liability (such as freight, demurrage, siding charges and other charges) which will be accrued due to use of the said siding.
3. There should be no inconvenience to the work of siding owner during the use of siding.
4. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
5. The grant of this co-user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
6. The siding will remain open for 24.00 hrs working.
7. In case of failure for making the payment of any dues, the facility will be withdrawn immediately.
8. In case of exigencies if any, the siding has to be vacated immediately.
