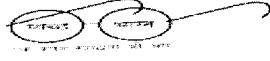

The contents of Railway Board's letter No. TC-I/2018/302/2 dated 27.02.2018 (Rates Circular No. 5 of 2018) is reproduced below for your information and guidance.

In terms of extant guidelines, the permission for operation of container trains by Private Container Operator (PCO) in railway owned terminals notified as Container Rail Terminals is valid up to 31.03.2018.

The matter has been reviewed and it has been decided to extend the currency extant instructions regarding operation of container trains by Private Container Operator (PCO) in railway owned terminals notified as Container Rail Terminals for a further period of one year i.e. upto 31.03.2019.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
