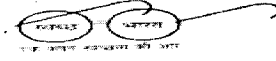

The contents of Railway Board's letter No.TCII/2642/2002/Milk dated 14.03.2018 (Freight Marketing Circular No. 07 of 2018) is reproduced below for your information and guidance.

Ministry of Railways have decided to increase the haulage rates for movement of Milk traffic from 01.07.2018 to 30.06.2019 as under :-

(a)	Haulage charges for loaded RMT	Rs. 87 per vehicle Km (For 8 wheeler Milk Tanker)
(b)	Empty RMTs for change of base or for POH	Rs. 43.50 per vehicle Km (For 8 wheeler Milk Tanker)

No Charges are leviable for empty movement of RMTs from unloading points to the loading points for re-loading.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.
