South Western Railway

1. **Sub: Closure of Parcel traffic at Krishnarajapuram (KJM) Station for through trains on Bengaluru Division.**

Ref: CCM/S.W.Railway's letter No. C.441/Station Closed for parcel/luggage traffic dt. 14.03.2018 (Comml.Circular (Coaching No. 18/2018).

With immediate effect Competent Authority has approved closure of Parcel traffic at Krishnarajapuram (KJM) station by all trains except those trains originating and terminating at Krishnarajapuram (KJM) station.

2. **Sub: Opening of Banaswadi (BAND) Railway station for Parcel and luggage traffic.**

Ref: CCM/S.W.Railway's letter No. C.441/opening of parcel Traffic/BAND traffic dt. 29.01.2018 (Comml.Circular (Coaching No. 08/2018).

With effect from 29.01.2018 Banaswadi (BAND) station on YPR -OML section of Bengaluru Division over South Western Railway is opened for inward & outward Parcel Traffic & Luggage Traffic.

3. **Sub: Handling of only inward parcel rakes at Karnal (KUN) station.**
