Sub:-Revision in the Rate of Siding charges for FCI Siding served by Mandir Hasaud station.

Ref:- This office Rates Circular No.121(G)/2017 dated 27.06.2017.

Consequent upon revision of all India Engine Hour Cost (AIEHC) for BG by Railway Board vide letter No.TC-I/2002/2014/5 dt.16.05.2017, the rate of siding charges earlier fixed for FCI Siding served by Mandir Hasaud station was revised w.e.f. 01.07.2017 vide this office RC No. 121(G)/2017 dt.27.06.2017.

Now, with the approval of competent authority and concurrence of Finance, the rate of siding charges has been revised for above sidings on round trip basis for both placement and drawing out of rake by single diesel train engine operation. The rate of siding charges is fixed to **Rs.83,813/- (Rupees Eighty Three Thousand Eight Hundred and Thirteen only).**

As the rate has been fixed for single diesel engine operation, the rate should be multiplied with number of engines in case of utilization of multiple engines.

This will have effective from **13.04.2018**. All concerned to please note and act accordingly.
