**Correction Slip No.39 to Indian Railways Commercial Manual-Vol.II for Item Nos. 19 & 38
Para 2425 may be revised as under:-**

- i. **Item No: 19** :- Refund of fares on unused and partially used tickets.
May be read as under:-

Item No.19:- “Refund of fares on unused and partially used tickets including difference due to AC failure.”

- ii. **Item No: 38** may be added as under:-

Item No.38:- Bank conveyance charges for hiring vehicle for depositing Government cash in the banks.
