Sub: Charges for GS coaches and sitting accommodation of SLR for running of special trains and Suvidha trains.

Ref.: Commercial Circular no. 8 of 2016 dated 03.02.2016 and Corrigendum to C.C. No.8 of 2016 dated 29.06.2016.

Reference Board's Commercial Circulars referred on the above subject. Ministry of Railways have decided to authorize CCMs of Zonal Railways to decide whether to treat the GS Coaches as reserved or unreserved in special trains when spare rakes (not lie over rakes) are utilized. In case, GS Coaches are to be treated as reserved coaches they shall be booked through PRS system with applicable special fare. However, when they are treated as unreserved coaches, they may be booked through UTS system with normal charges for unreserved accommodation as applicable for superfast Mail/Express trains.

2. All other terms and conditions for running of Suvidha trains; special trains on special charges shall remain unchanged.

3. This issues with the concurrence of Finance Directorate of the Ministry of Railways.
