Sub: Withdrawal of service charge of ₹30/- applicable on transactions against Credit and Debit cards for purchasing journey tickets.

Ref: Commercial Circular No. 26 of 2016 dated 18.05.2016

Vide Commercial Circular No. 26 of 2016 dated 18.05.2016, Service charges of ₹30/- applicable on transactions against credit and debit cards for purchasing journey tickets at PRS counters was withdrawn w.e.f.01.06.2016. Now, Ministry of Railways have decided to withdraw the service charge of ₹30/- applicable on transactions against credit and debit cards for purchasing journey tickets at UTS counters with immediate effect. Now no service charge shall be levied on purchase of journey tickets at UTS counters through Credit/Debit cards.


