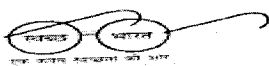

The contents of Railway Board's letter No. TC-I/2017/109/5 dated 18.05.2018 (Corrigendum No.4 to Rates Master Circular/ Weightment/2014/0) is reproduced below for your information and guidance.

In terms of Board's letter No. TC-I/2017/109/5 dt. 24.11.2017, guidelines regarding dispensation from mandatory (100%) weightment in the case container rake loaded with containers carrying standard bags of uniform size have been issued. These guidelines are valid upto 24.05.2018 .

The matter has been examined and it has been decided to extend the currency of above mentioned guidelines beyond 24.05.2018 up to 31.03.2019.
