The contents of Railway Board's letter No.TC-I/2014/302/2 dated 06.07.2018 (Corrigendum No.18 to Rates Master Circular/CRT-CCR-Hub & Spoke/2015/0) is reproduced below for your information and guidance.

Please refer to Board's letter No. 2017/TT-III/73/3 dated 06.07.2018 which approval has been accorded for movement of CP coke in containers.



CP Coke when transported in containers shall be charged at Container Class Rate (CCR) i.e. by applying 15% concession on Applicable Class Rate as published in Goods Tariff (No. 48 Pt.I Vol -II) and as amended from time to time, subject to the condition that the entire container rake shall contain only CP coke i.e. no other commodity (whether notified or otherwise) shall be loaded alongwith CP coke in the said container rake. While booked under "Hub & Spoke", CP coke container rake shall not have any other commodity.

This instructions will come into force with effect from 11.07.18.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.

All concerned to note and act accordingly.
