Sub: Notification for charging of freight on through distance basis in the private siding of Bharat Aluminium Company Ltd. (TPSK) served by Korba station.

The private siding of Bharat Aluminium Company Ltd. (TPSK) served by Korba station has been electrified and is qualifying for charging of freight on **through distance basis**. There are two exchange yards in this siding. The freight will be charged by reckoning the distance of farthest point of exchange yard i.e. **Korba (KRBA) + 7.49 Kms**. Accordingly, placement/drawing out will be done by Railway engine to/from exchange yard only.

TPSK siding is a Non-EOL siding, staff cost will continue to be levied from the siding owner as usual.

The above instruction will have effective from **30.08.2018**. Necessary RBS data may be update accordingly. This has the approval of competent authority.
