Sub: Grant of Co-user permission to use Line no.1 of Hirri Mines Siding, Dadhapara owned by SAIL/Bhilai Steel Plant for handling Coal traffic.
Ref: This office rates Circular No.38(G)/2018 dated:05.03.2018.

With the approval of competent authority (i.e.PCOM & PCCM) temporary permission was granted to M/s Mahavir Coal Washeries Pvt. Ltd. to use the Line no.1 of Hirri Mines Siding, Dadhapara owned by SAIL/Bhilai Steel Plant as a co-user for inward and outward traffic of coal ("D" priority) up to 06.09.2018. Now the permission has been extended for further period of one year i.e. from 07.09.2018 to 06.09.2019 on following terms and conditions:-

1. The first priority will be given to the traffic of SAIL for placement of empties and withdrawal of rakes.

2. Your firm will be responsible for clearance of all tollage liability (such as freight, demurrage and other charges) which will be accrued due to use of the said siding.
3. There should be no inconvenience to the work of siding owner during the use of siding.
4. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
5. The grant of this user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
6. The siding will remain open for 24.00 hrs working.
7. In case of failure for making the payment of any dues, the facility will be withdrawn immediately.
8. In case of exigencies if any, the siding has to be vacated immediately.
