






Sub: Incentive Scheme for Freight Forwarders

Ref: Board's Rates Master Circular/FIS/2015/0 and corrigenda thereto.

1. Please refer to the Para 2.5 of Rates Master Circular/FIS/2015/0 vide which Goods Sheds were notified under Permitted Terminals for Incentive Scheme for Freight Forwarders.
2. The Matter has been reviewed by the Competent Authority, it has now been decided that Private Freight Terminals shall also be included in the Permitted Terminals for Incentive Scheme for Freight Forwarders.
3. All other terms and conditions mentioned in Rates Master Circular/FIS/2015/0 shall remain unchanged.
4. These instructions shall come into effect w.e.f. 28.09.2018 for a initial period of six (06) months i.e. upto 27.03.2019.
5. Periodic review may be undertaken and feedback be apprised to Board's office for further continuation of the scheme.
6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
