


The contents of Railway Board's letter under reference No. TCR/1394/2004/2 Vol. IV-Pt.I dated: 11.10.2018 (Corrigendum No.22 to Rates Master Circular/PCC/2015/0) is reproduced below for your information and guidance.

1.0 Please refer to Annexure III to Rates Master Circular under reference wherein list of CC+8 routes is prescribed. Now, sanction of the Central Government is hereby accorded to include following routes in the list of already identified CC+8 routes.


Railway	Name of Route
WR	Ex Dry Bulk Terminal Tekra (DBTK)- Gandhidham (GIM)
ECoR	By Pass Line between Sukinda Road to Jajpur Keonjhar Road. (avoiding jakhapura) ( KUR division)
ECoR	Lanjigarh to Junagarh Road (SBP division)

2.0 All other details of the Rates Master Circular & Corrigenda thereto under reference will continue to apply unchanged.

3.0 These instructions shall come into effect from **14.10.2018** and shall remain valid till further advice.
