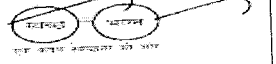

Sub: Issuing of RR non submission of TDS details by customers.

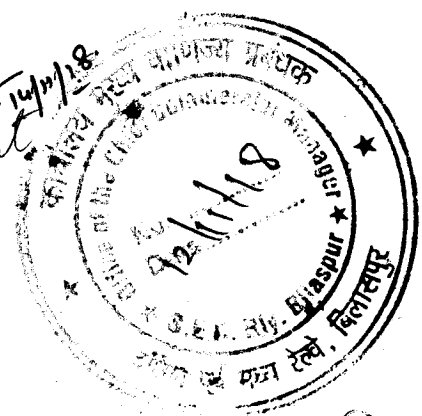
As per laid down guidelines, goods clerk will issue RR for total freight + 5% GST and will ask from the customer about the declaration for reducing the total value of RR by TDS amount of 2% for transportation of commodities by goods train.

In case of non-furnishing of TDS details by the customer, the goods clerk shall issue RR with appropriate GST i.e. 5% at present. Only certain categories of customers (Para 3 of Board's letter of even number dated 25.09.2018) are authorized to deduct TDS.
