



The contents of Railway Board's letter No. TC-I/2014/302/2 dated 14.11.2018 (Corrigendum to Rates Circular No. 20 of 2018) is reproduced below for your information and guidance.

Please refer to Rates Circular No. 20 of 2018 circulating revised rates of 'Haulage Charge per TEU' for movement of containers in privately owned wagons, applicable in the case of commodities other than notified commodities, to be effective from 15.11.2018.

The matter has been examined and it has been decided to change the date of implementation of the above mentioned revised rates of 'Haulage Charge per TEU' w.e.f. 01.12.2018 instead of 15.11.2018.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
