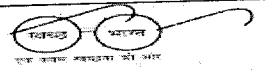

(Rates Circular No.22 of 2018) is reproduced below for your information and guidance.

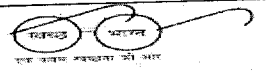
1. In terms of Rates Circular No. 11 of 2018 dated 31.05.2018, the freight rates for
