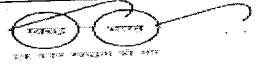

The contents of Railway Board's letter No. TC-I/2010/108/4 Pt. dated 12.12.2018

As per extant guidelines, designed tare weight of wagons should be taken as the  
benchmark for reckoning of overloading in any wagon. The designed tare weights of  
different types of wagon are stipulated vide Board's letters under reference.

The designed tare weight of BFNSM22.9 wagon as furnished by Mechanical Dte.  
of Railway Board shall be taken as under-

Type of wagon	Designed Tare Weight
BFNSM22.9	22.00t
