The contents of Railway Board's letter No. TC-I/2014/302/02 dated 12.12.2018 (Corrigendum to 2 to Rates Circular No. 20 of 2018) is reproduced below for your information and guidance.

- 1.0 Please refer to Rates Circular No. 20 of 2018 regarding 'Haulage Charge per TEU' for movement of containers in privately owned wagons applicable in the case of commodities other than notified.
- 2.0 The matter has been reviewed and it has now been decided to:
 - 2.1 grant 25% discount on the extant Haulage rate per TEU for movement of empty containers; and
 - 2.2 grant a similar discount of 25% discount on the extant Haulage rate per TEU for movement of empty flat wagons.
- 3.0 These instructions will come into force w.e.f. 01.01.2019 and shall remain valid for one year i.e. upto 31.12.2019. A review shall be taken up after 30.06.2019. Zonal Railways must continuously assess the impact of discount granted and furnish their feedback to Board.
- 4.0 This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
