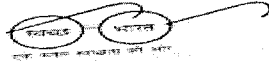

The contents of Railway Board's letter No. TCR/1394/2004/2 Vol.IV -Pt.I dated
20.12.2018 (Corrigendum No. 24 to Rates Master Circular/PCC/2015/0) is reproduced below

- 1.0 In terms of Board's letter referred at (i) above, Eastern Railway have forwarded
proposal with due approval of the General Manager to include the section- Saktigarh
(SKG)- Bandel (BDC) - Naihati (NH) (Dn line) in the CC+8 route.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference wherein list
of CC+8 route is prescribed. Now, sanction of the Competent Authority is
hereby accorded to include following route in the list of already indentified CC+8
routes:

- 2.0 All other details of the Rates Master Circular & Corrigenda thereto under reference
will continue to apply unchanged.
