**Rates Circular No.220(G)/2018**

1. The linkage programme should be obtained from EDRM/KOLKATA for movement of coal to power houses and other consumers.
2. The first priority will be given to the traffic of siding owner for placement of empties and withdrawal of rakes.
3. The siding owner will be responsible for clearance of all the liability (such as freight, demurrage charges and other charges) which will be accrued due to use of siding.
4. Railway will not be responsible for any dispute arises between co-user firm and the siding owner.
5. The Railway reserves the right to withdraw the permission at any time without serving any prior notice or assigning any reason.
6. The siding will remain open for 24.00 hrs. working.
7. In case of failure in making the payment of any dues, the facility will be withdrawn immediately.
