

Reference is invited to this office Rates Circular under reference, wherein private siding Junadih Rapid Loading System of SECL (Silo 3 & 4) served by Gevra Road station on Bilaspur Division was opened temporarily as an independent booking point for handling full rake for outward traffic of Coal for a period of three (03) months (i.e. from 27.10.2018 to 26.01.2019) on actual siding charge basis.

With the approval of competent authority (i.e. PCCM), now it is further extended for the period of 03 (three) months i.e. from 28.01.2019 to 27.04.2019.
