




Sub: Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD).

Ref: 1. Board's letter of even number dated 28.09.2018 (Rates Circular No. 16 of 2018)
2. Board's letter No.TCR/1078/2018/04 Pt.2 dt. 15.01.2019.

1. In terms of Board's letter under reference, revised guidelines for Liberalized Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD) were issued.
2. Sanction of the Competent Authority is hereby accorded to delete the intra-zonal TEFD stream WAT-KUR (BRST) appearing at S.No.3, Sub-S.No.3.2, in Annexure 2B of Rates Circular No.16 of 2018 for the pure rake of BOST group of wagons under TEFD. This stream shall continue to be available for concession under TEFD for rest of the OPEN wagons under annexure 2B.
3. All other terms and conditions stipulated in above referred Rates Circular shall remain unchanged.
4. These instructions will come into force w.e.f. 07.02.2019.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of the Ministry of Railways.

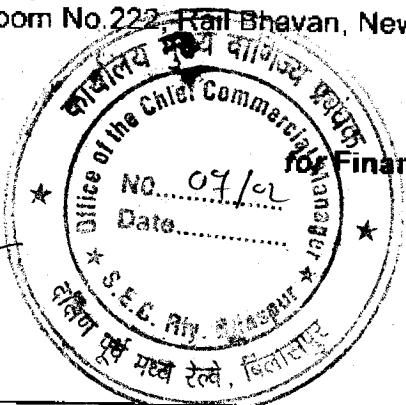
