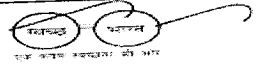

The contents of Railway Board's letter No. TCR/1394/2004/2 Vol.IV -Pt.I dated 07.02.2019 (Corrigendum No. 25 to Rates Master Circular/PCC/2015/0) is reproduced below for your information and guidance.

- In terms of Board's letter referred at (i) above, Eastern Railway have forwarded proposal with due approval of the General Manager to include the section- Gosaingram - Nalhati Jn. (GSGB) - (NHT) (Up & Dn line) including Gosaingram - Poradanga (Y- connection) in the CC+8 route.
- Please refer to Annexure III to Rates Master Circular referred at (ii) above wherein list of CC+8 route is prescribed. Now, sanction of the Competent Authority is hereby accorded to include following route in the list of already indentified CC+8 routes:
