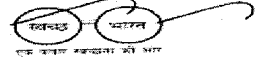

The contents of Railway Board's letter No. TC-I/2014/302/2 dt. 27.03.2019 (Corrigendum
No. 22 to Rates Master Circular/CRT-CCR-Hub & Spoke/2015/0) is reproduced below for your
information and guidance.

Please refer to Corrigendum 10 to Rates Master Circular/CRT-CCR-Hub & Spoke/2015/0
stipulating guidelines for levy of Haulage Charge in the case of notified commodities at prevailing
Haulage Rate per TEU basis for '50 or less than 50 containers' in a rake; at Container Class Rate for
'more than 50 containers' in a rake and applicability of this benefit under Hub & Spoke System of
charging. These guidelines are valid up to 11.04.2019 as per Corrigendum No.15.

The matter has been reviewed and it has been decided to extend the currency of above
mentioned guidelines beyond 11.04.2019 till further advice.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of
Finance Dte. of Ministry of Railways.
