


In terms of Rly. Board's letter under ref. no.1, free time for loading of Coal and Iron ore was reduced from 5:00 hrs. to 3:00 hrs for 12 private sidings and 1 (one) Goods Shed vide this office Rates Circular No.21(G)/2018 dated:13.02.2018 and further extended time to time.

Now, Railway Board vide their letter under ref. No. 3 (Corrigendum No.07 to Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0) has been decided to extend the currency of above mentioned guidelines beyond 31.03.2019 for a further period of two years i.e. up to 31.03.2021.
