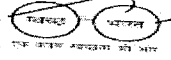

The contents of Railway Board's letter No. TC-1/2014/302/2 dt.02.04.2019
(Corrigendum No. 23 to Rates Master Circular/CRT-CCR-Hub & Spoke/2015/0) is reproduced
below for your information and guidance.

Please refer to Para 1.2.3 of Chapter-II of Rates Master Circular under reference which
stipulates that in case of CR Coils (Cold Rolled Coils) which falls under the notified commodity
group 'Iron and Steel', the container class rate will be levied by applying 20% concession on
applicable class rate (i.e GTR minus 20%) as published in Goods Tariff (No.48 currently No.49,
Pt.I of Vol. II& Part II) subject to fulfillment of terms and conditions mentioned therein. These
instructions are valid up to 10.04.2019 as per Corrigendum No.16 dt. 19.03.2018.

The matter has been reviewed and it has been decided to extend the validity of the
above instructions beyond 10.04.2019 for a further period of one year i.e. upto 10.04.2020 on the
same terms and conditions.

This issues in consultation with Traffic Transportation Dte. and with the concurrence
of Finance Dte. of Ministry of Railways.
