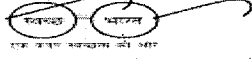

The contents of Railway Board's letter No. TCR/1394/2004/2 Vol.IV-Pt.I dated 04.04.2019
(Corrigendum No. 27 to Rates Master Circular/PCC/2015/0) is reproduced below for your information
and guidance.

- 1.0 In terms of Board's letter referred at (i) above, Central Railway have forwarded proposal with
due approval of the General Manager to include the section- Chalisgaon - Dhule (CSN -DHI);
Jalamb-Khamgaon (JM -KMN) and Daund- Baramati (DD - BRMT) in the CC+8 route.
- 2.0 Please refer to Annexure III to Rates Master Circular referred at (ii) above wherein list of
CC+8 route is prescribed. Now, sanction of the Competent Authority is hereby accorded to
include following route in the list of already identified CC+8 routes:
