The contents of Railway Board's letter No. TCR/1394/2004/2 Vol.IV-Pt.I date 11.04.2019  
(Corrigendum No. 29 to Rates Master Circular/PCC/2015/0) is reproduced below for your information  
and guidance.

1.0 In terms of Board's letter referred at (i) above, Eastern Railway have forwarded proposal with  
due approval of the General Manager to include the section- Naihati Link Cabin - Halisahar  
(NHLC-HLR) bypass line in the CC+8 routes.

2.0 Please refer to Annexure III to Rates Master Circular reference wherein list of CC+8 routes is  
prescribed. Now, sanction of the Competent Authority is hereby accorded to include  
following route in the list of already indentified CC+8 routes:

3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference will continue  
to apply unchanged.
