The contents of Railway Board's letter No. TCR/1394/2004/2 Vol.IV-Pt.I dated 22.05.2019 (Corrigendum No. 02 to Rates Master Circular/PCC/2019/0) is reproduced below for your information and guidance.

- 1.0 In terms of Board's letter referred at (i) above, South Western Railway have forwarded proposal with due approval of the General Manager to include the section- Londa -Miraj (LD-MRJ) in the CC+8 routes.
- 2.0 The proposed section Londa -Miraj (LD-MRJ) is already mentioned in Annexure -II of Rates Master Circular under reference at (ii) above, as Expected CC+6 routes. The same may be treated as deleted.
- 3.0 Please refer to Annexure III to Rates Master Circular referred at (ii) above wherein list of CC+8 route is prescribed. Now, sanction of the Competent Authority is hereby accorded to include following route in the list of already indentified CC+8 routes:
