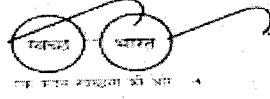

Sub: Inclusion of wagon type BAFRDR in FOIS.

Ref: Board's Rates Circular Master Circular/PCC/2019/0 dated 16.05.2019 and Corrigendum thereto; & Rates Master Circular/2016 dated 14.07.2016 on Block Rake/Mini Rake/Two Point Combination etc.

A proposal for inclusion of wagon type BAFRDR in FOIS and fixation of Permissible Carrying Capacity (PCC); Standard Rake Size; Minimum number of wagon to be loaded; & Loading Tolerance for this wagon type was under consideration of Board.

The issue has been examined. It has now been decided by the Competent Authority that for the purpose of charging, wagon type BAFRDR shall be treated as under:
