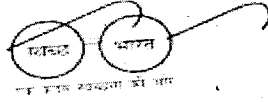

The contents of Railway Board's letter No.TCR/1078/2018/04 dated 18.06.2019 is (Corrigendum No. 04 to Rates Circular No. 16 of 2018) reproduced below for your information and guidance.

1. In terms of Rates Circular under reference, guidelines for Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD) were issued.

2. The matter has been reviewed. It has now been decided to delete JHS Divn. Listed as enroute Division for Open Stock for empty flow from JBP Divn. (WCR) to MGS Divn. (ECR) in Annexure-3B of Rates Circular No. 16 of 2018. Accordingly, following modification in the Annexure -3 B attached with Rates Circular No. 16 of 2018 may be done:
