


**Sub:- Grant of Co-user permission to use the private siding of M/s Ind synergy Limited, (PISK) served by Kotarlia station.**

With the approval of competent authority (i.e.PCOM & PCCM), temporary permission is hereby accorded to **M/s Container Corporation of India Ltd.** for use of private siding of M/s Ind Synergy Limited (PISK) served by Kotarlia station, valid upto **09.06.2020**, as a co-user for loading of **Sponge iron and Iron & Steel** in containers on following terms and conditions:-

1. The traffic belonging to siding owner only can be handled i.e. no 3<sup>rd</sup> party Cargo will be handled.
2. The first priority will be given to the traffic of M/s Ind Synergy Limited, for placement of empties and withdrawal of rakes.
3. Siding owner will be responsible for clearance of all tollage liability (such as freight, demurrage and other charges) which will be accrued due to use of the said siding.
4. There should be no inconvenience to the work of siding owner during the use of siding.
5. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.

6. The grant of this user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
7. The siding will remain open for 24.00 hrs working.
8. In case of failure for making the payment of any dues, the facility will be withdrawn immediately.
9. In case of exigencies if any, the siding has to be vacated immediately.
