उपर्युक्त विषयक रेलवे बोर्ड के पत्र संख्या TC.II/2080/12/Livestock दिनांक 24/07/2019 (Freight Marketing Circular No.20 of 2019), आपके सूचनार्थ एवं आवश्यक कार्यवाही बाबत पूर्ण विवरण नीचे दिया जा रहा है।


Vide Freight Marketing Circular No. 07 of 2016 dated 27.06.2016, charges for transportation of all animals including wild animals & birds in Parcel vans and Brake vans were revised w.e.f.15.07.2016, from Scale- 'L'+25% to 'L'- Scale irrespective of the category of trains. The revised charges were initially applicable upto 30.03.2017 and after review, further extended from time to time, last being up to 30.06.2019 vide FM Circular No. 32 of 2018 dated 31.12.2018/01.01.2019.

2. The matter has been reviewed and the Ministry of Railways have now decided that the charges for transportation of all animals, including wild animals & birds, in Parcel -vans and Brake -vans shall henceforth be at Scale-'L'+25% instead of 'L'-Scale.
3. No Free allowance shall be permissible in case of booking of animals/birds as luggage.
4. Apart from other charges like development charge, GST etc shall be levied separately as per instructions notified from time to time.
5. Other terms and conditions for booking of animals including wild animals/birds will remain same.
6. This issues with the Concurrence of the Finance Directorate of the Ministry of Railways.
