in open wagon.**



Reference is invited to this office Rates Circulars No. 181(G)/2018 dated: 01.10.2018, wherein Akaltara Goods Shed (Godown side) was opened for outward loading of 'Dolomite' in covered wagon in addition to food grain.

Now, with the approval of the competent authority (i.e. PCOM & PCCM), the commodity 'Dolomite' is permitted in open wagon also for a period of 6 (Six) months on experimental basis.
