1. In terms of Rates Circular No.04 of 2016 dated 11.02.2016, the Hire Charges on Wagons interchanged were notified and revised from 25.02.2016.
2. The matter has been reviewed and sanction of the Competent Authority is hereby accorded to effect the enhancement of Hire Charges on Wagons interchanged as follows:

a) Hire Charges for Inter-Railway Financial Adjustment:

3. These Rates shall apply on other types of wagons according to their equation in terms of 8 wheelers.
4. These rates shall apply to all Port Trust Railways.
5. These rates shall come into force w.e.f. 06.08.2019 and shall remain valid till 31.08.2020.
