

The following terms and conditions to be followed:-

1. The first priority will be given to the traffic of M/s Paras Power & Coal Benefication Ltd.(PPBG) for placement of empties and withdrawal of rakes.
2. The siding owner will be responsible for clearance of all tollage liability (such as freight, demurrage and other charges) which will be accrued due to use of the said siding.
3. There should be no inconvenience to the work of siding owner during the use of siding.
4. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
