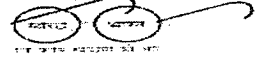

Sub: Collection of Wagon Registration Fee from Premier Customer

Please refer to SECR's letter No.Optg/SECR/Gds/Coal/5D-I dt.06.08.2019 wherein Railway has cited a situation when a Premier Customer does not commence loading before expiry of the free time leading to cancellation of his subsequent indent(s) by the Railway and has sought a clarification whether Wagon Registration Fee will be collected for one rake or for all the rakes so cancelled.

In this regard relevant provisions of Chapter-II of Goods Tariff are reproduced below for the guidance of the railway -

"Para 201 (6) No Wagon Registration Fee will be required to be paid in respect of the following traffic-

(a): Traffic in any commodity offered by Premier Customers viz. Platinum, Gold, Silver card holders from their siding.

Note: An amount equal to Wagon Registration fee will be collected from Premier Customers, if they cancel their indent under any of the circumstances, notified in Rule 201(15)."

"Para 201(15) Registration Fee will be forfeited under any of the following circumstances-

(d): When a wagon is supplied to an indenter but he does not commence loading it, before the expiry of the free time allowed for loading.

Note:- (1) Whenever the registration is forfeited, the corresponding indent will also be treated as cancelled."

It is inferred from the above that in case when few indents have been placed by a Premier Customer and a rake is supplied against one of such indents and if the customer does not commence loading of the rake before expiry of prescribed free time, then WRF will be collected for one indent and not for corresponding indent(s) which are treated as cancelled, provided rakes have not been allotted against such indents.
