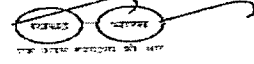

Reference has been received seeking clarification regarding compulsion of online indenting to opt for eT-RR and modification in Forwarding Note.

In this regard following is advised -

- One time registration of customer (i.e. consignor & consignee both) is required for the purpose of availing the facility of eT-RR. However, on-line indenting is not mandatory for opting for eT-RR. Customer (consignor) can place manual indent and yet opt for eT-RR.
- Customer is permitted to change details like consignee name, code, destination, bank account details etc. in the Forwarding Note until preparation of Railway Receipt. However, number of Forwarding Notes cannot be changed.
