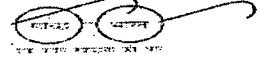

- 1.0 In terms of Board's letter referred at (i) above, South Central Railway has forwarded proposal with due approval of the General Manager to include Vijayawada-Gudivada-Bhimavaram-Nidadavolu (Including bypass line at Bhimavaram), Bhimavaram-Narasapur and Gudivada-Machilipatnam (SL) BG Section in the CC+8 routes.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include **Vijayawada-Gudivada-Bhimavaram-Nidadavolu (Including bypass line at Bhimavaram), Bhimavaram-Narasapur and Gudivada-Machilipatnam (SL) BG Section** route in the list of already identified CC+8 routes.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 4.0 These instructions shall come into effect from 21.09.2019 and shall remain valid till further advice.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
