Sub:- Policy Guidelines - Supplementary charges on Transportation Products.

Ref:- Railway Board's Rates Master Circular dated 14.07.2016 on Block Rakes/Mini Rake/ Two Point Combination etc./2016/0 and Corrigenda thereto.

The contents of Railway Board's letter No. TCR/1017/2009/2 dt.20.09.2019 (Corrigendum No. 24 to Rates Master Circular dated 14.07.2016 on Block Rakes/Mini Rake/Two Point Combination etc.) is reproduced below for your information and guidance.

1. Please refer Corrigendum No. 22 to Rates Master Circular dated 14.07.2016 on Block Rakes/Mini Rake/ Two Point Combination etc. dated 12.09.2019 whereby withdrawal of 5% Supplementary charge on Base Freight Rates for Mini Rakes and Two Point Rakes linked with Para 4.0(7), 5.0(7) and 8.0 (10) have been withdrawn w.e.f. 01.10.2019 till further advice.
2. The matter has been further reviewed and Competent Authority has decided that 5% Supplementary charge on Base Freight Rates for Two Point Rakes (other than covered wagons) as per Para 7.0(6) have also to be withdrawn till further advice.
3. All other terms and conditions prescribed in the above referred Rates Master Circular and Corrigenda thereto shall remain unchanged.
4. These instructions shall come into force w.e.f. 01.10.2019.
5. This issues in consultation with Traffic Transportation, Directorate and concurrence of Finance Directorate of Ministry of Railways.
