


The validity was from 01.04.2019 to 30.09.2019.

With the approval of competent authority (i.e. PCOM & PCCM), now above co-user permission has been extended for further period of six month. The details are as under:-

Rates Circular No.166(G)/2019

The following terms and conditions to be followed:-

1. The linkage programme should be obtained from EDRM/KOLKATA for movement of washed coal to power houses and other consumers.
2. The firm should explore the feasibility for loading on both spurs simultaneously to reduce the loading time.
3. The siding owner will be responsible for clearance of all tollage liability (such as freight, demurrage and other charges) which will be accrued due to use of the said siding.
4. The Railway reserves the rights itself to withdraw the permission at any time without serving any prior notice or assigning any reason.
5. The grant of this co-user permission will be without prejudice to the fulfillment of all terms and conditions of the siding.
6. The siding will remain open for 24.00 hrs. working.
7. In case of failure for making the payment of any dues, the facility will be withdrawn immediately.
8. In case of exigencies if any, the siding has to be vacated immediately..
